Privacy Policy & Waiver Release

At the Omeme Curling Centre, we are committed to collecting, using and disclosing your personal information responsibly and to maintaining the accuracy, confidentiality and security of such personal information.

Personal information includes information that tells us specifically who you are, such as your address, telephone number, e-mail address, and age. However, publicly available information, such as a public directory listing of your name, address and telephone number is not considered personal information.

We have adopted the following privacy policy that guides how we collect, use and disclose personal information about our members and prospective members. Our intent is to balance our legitimate business interests in collecting, using and disclosing your personal information against your reasonable expectations of privacy.

Definitions

In this policy:

- a) "business" means the business of operating the Omeme Curling & Rec Centre
- b) "membership" means membership at the Omeme Curling Centre
- c) "we", "us", "our" and "Club" refer to the Omeme Curling Centre, located at 15 James St., Omeme ON, K0L 2W0
- d) "web site" refers to the web site found at www.omemeecurling.com

Collection of Personal Information

Our primary purpose in collection personal information from you and about you is to maintain an accurate membership file. We only collect personal information that we consider necessary for achieving this purpose and to permit us to conduct our Curling Centre business.

Use of Your Personal Information

We may use the personal information we collect from and about you to:

- a) ensure the provision of quality member services
- b) inform you about services, update and events
- c) enable us to contact you and communicate with you
- d) invoice you for products, services and membership renewal
- e) assist us in complying with legal and regulatory requirements

We may use personal information about you, in a **non-personally identifiable manner**, to improve our marketing and promotional efforts, to analyze membership, to customize our web site content and layout and to comply with membership affiliation in the Ontario Curling Association.

Disclosure of Personal Information

As a matter of policy, we do not sell, rent or lease any of your personal information to third parties without your explicit consent. We may disclose your personal information as may be required by law or to your legal representative if we are satisfied that the individual is requesting the information on your behalf.

You may access, review and/or change the personal information we have in our files by submitting a written request to our Privacy Information Officer. We ask that you promptly advise us of any changes to your information.

Upon your written request, we will destroy, as soon as reasonably possible and in accordance with our internal policies and applicable law, any and all personal information that we have in our files about you. Notwithstanding the foregoing, we will retain in our files some personal information in order to enable us to collect any unpaid accounts and/or as may be required by law.

Other Information Collectors

Except as otherwise expressly included in the Privacy Policy, this document only addresses the collection, use and disclosure of personal information we collect from and about you. To the extent that you disclose your personal information to other parties, different rules may apply to their collection, use or disclosure of such personal information. Since we do not control the privacy policies of third parties, you are subject to the privacy policies of such third parties.

Protecting Your Privacy

The personal information that is retained by us is kept in a secure environment and we use reasonable procedural and technical safeguards to protect your personal information against loss, theft and unauthorized access or disclosure.

Amendments to This Policy

We may amend this Privacy Policy at any time by mailing and/or posting the amended items on the web site and/or at the Club. All amended terms shall automatically be effective five days after mailing or posting.

I acknowledge that I have read and voluntarily signed this release and waiver of liability and indemnity agreement, and further agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
